

Clarity and Precision	Questions are rarely vague; well-prepared candidates can answer confidently
Strong Interlink with Current Affairs	Parliamentary bills, constitutional amendments, Supreme Court verdicts frequently asked
Scoring Potential	With systematic revision, aspirants can score 12+ questions



Why PYQ Analysis in Polity Matters

Aspect	Explanation
Identifies Core & Repeated Topics	Fundamental Rights, DPSPs, Judiciary, Federalism, Parliament
Clarifies Conceptual Depth	Tests real understanding, not rote learning
Guides Study Prioritization	Helps identify high-yield vs low-yield areas
Reveals Current Affairs Linkage	Constitutional provisions linked with recent events (e.g., ordinances, Article 370)
